III. Approval of Agenda –

- A. Approved without changes.

IV. Approval of Previous Meeting Minutes– [10-June-2024](#)

- A. Button moved to approve previous minutes, McCluskey seconded the motion. All ayes. Motion passed.

V. Chairperson's Opening Comments - None**VI. Programs, Presentations, Invited Guests or Speakers – None Scheduled****VII. New Business and Action Items –****A. Approval of Expenditures****1. Administration (1202) – None****2. Des Moines PSAP (1203) – [Attachment 1](#)**

- a. \$130,859.80 – Keltek Incorporated, 20 Toughbooks with docking stations, extended memory capacity, and warranty. For use in dispensation of emergency calls for services. Purchase has been placed with approval of Des Moines City Council. See Attachment 1. There were no questions or further discussions on this item. Chiappano motioned to approve the expenditure. Button seconded the motion. All ayes. Motion passed.

3. PCSO PSAP (1204) – None

4. Westcom PSAP (1205) – [Attachment 2](#)

- a. \$69,428.14 – City Professional/Technical Services. See Attachment 2. McCluskey motioned to approve this expenditure. Brockman seconded the motion. All ayes. Motion passed.
- b. A discussion unrelated to the figure needing approval was had on Item #11 listed in the reimbursement packet in Attachment 2. Item #11 is a \$360 charge to Urbandale FD from CentralSquare for an annual subscription fee for Field Ops. This should not be paid by 911 funds. The \$360 will be subtracted from the total amount requested for reimbursement from the City of West Des Moines before payment.

5. Joint Projects (1206) – [Attachment 3](#)

- a. Verification of Joint 911 Lines paid through this account, paid with 1202. See Attachment 3.
 1. \$76.25 – Huxley Communications
 2. \$470.83 – Kinetic Business
 3. \$353.44 – CenturyLink
- b. Discussion was had on the origin of the charges listed in item 5a. It is unclear what these lines are for and where or who they connect to. All three bills are sent straight to Polk County Central Accounting where they are paid upon receipt. The 911 Coordinator will do research into this and bring an update to the next meeting. McCluskey motioned to defer this until the next meeting pending more information. Button seconded the motion. All ayes. Motion to defer passed.

6. Catastrophic Reserve (1207) – None

B. Distributions from Clearing Account (1208) – Distributions expected once Central Accounting verifies end of year balances, expected in August.

VIII. Old Business –

- A. RINO 2.0 Contract Cancellation - Aureon contract cancelled, services associated with RINO 2.0 terminated. Metro Interop provided update and requested to turn in all equipment by August 1. Polk County reported their equipment has been turned in. Westcom has not turned in their equipment. They have other services through Aureon and need to confirm their router is safe to unplug without disruption. Des Moines was not able to confirm whether theirs had been turned in.

IX. Reports and Program/Project Updates

A. Budget and Finance

1. Fiscal Agent Transition – Fiscal policy in place. Will monitor for performance and compliance.
2. Monthly Budget Reports – Year to date ending 30-June-2024.

3. **Undesignated Funds** – There has been a pushback in legislation to try to take back undesignated funds. End of Year reports should reflect the total cost of running a PSAP to help this. Reserves are acceptable but should have a designation with a basic description of how the funds will be used in the future.
4. **State of Iowa End of Year Pass-Through** – State is unable to pass any money through due to the current amount in the surplus being less than the 12.5% of annual revenue they are allowed to maintain in case of a catastrophic failure. In previous years we received about \$36,000.
5. **Surcharge Working Group** – Proposal in the works to have the state also take in the wireline surcharge funds. The proposal includes an increase from \$1.00 per line to \$1.20. An adjustment to the current disbursement formula would keep Polk County from losing a significant amount of money from this change. Current formula divides the wireless funds by square area (65%) and call count proportionate to the total in the state (35%). The new formula changes these percentages to 50/50. Smaller counties will see an increase, larger counties will see their funding stay about the same. Our estimated annual funding would be about \$18,000 less. This is all pending legislation. A potential offset to this loss is the recent FCC ruling on 911 cost recovery being a “cost of doing business” rather than something we’re charged for.

B. PSAP Advisory Committee

1. **Des Moines Training Grant** – Request submitted to Polk County EMA by Des Moines PD to host a Priority Dispatch Emergency Medical Dispatch (EMD) training course. Request has been submitted to the State.

C. Metro Interoperability Committee

1. **Unified Concept of Interoperability (UCOI)** – Concept is effectively already being used in the region. Discussion was had on ways to incorporate it into a unified communications plan that matches between the police, fire, and EMS associations and how to ensure agencies are obligated to follow it.

D. CAD Improvement Project

1. **Operations Subcommittee** – Testing conducted on 7/31/2024 went well. Three issues were identified: (1) Des Moines radio aliases were unable to be seen on Harris radios, (2) Inability to patch encrypted channels, (3) Emergency activations were only tested on direct channels. They did work as intended there.
2. **Technical Subcommittee** – No update. This has been on hold pending Westcom upgrades.
3. **Policy and Budget Subcommittee** – No update.
4. **The Authority Working Group** – No update. Did not meet in July.

E. Administration

1. **911 Coordinator Vacancy** – New 911 Coordinator, Lynn Tazzioli, started 15-July-24.

WHEREAS, the Police Department has requested the Finance Department's Procurement Division issue a purchase order for the purchase of Twenty Panasonic Computers for use in police vehicles; and

WHEREAS, the Panasonic Computers for use in police vehicles is being procured through the competitive bid process using the State of Iowa Participating Addendum #21309A from Whelen, Inc., through its authorized distributor Keltek, Inc. and the NASPO ValuePoint Master Agreement Number 165264; and

WHEREAS, Municipal Code section 2-726 (b18) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, Panasonic Computers for use in police vehicles is being purchased from Keltek Inc. (205 N. High Street Baxter, IA, 50028,) a division of Rayser Holdings, Inc. (Michelle Jensen, President & CEO), in the amount of \$130,859.80 utilizing State of Iowa Participating Addendum #21309A and NASPO ValuePoint Master Agreement Number 165264; and

WHEREAS, funding is available from the 911 Reimbursement FY2025 Recommended Budget.
